Brief Biography

An internationally recognized expert in the field of Post-Traumatic Stress Disorder (PTSD), John P. Wilson received his Doctorate in Psychology from Michigan State University. He is currently Professor of Psychology at Cleveland State University in Cleveland, Ohio. Dr. Wilson is a founding member and past president of the International Society for Traumatic Stress Studies (ISTSS) and a Fellow of the American Institute of Stress. In 1998, he became the executive director of the Forensic Center for Traumatic Stress; an organization dedicated to service provision in legal litigation and related matters.

Dr. Wilson is the author of eleven books and over 20 monographs on traumatic stress syndromes. Among his most recent books are *The International Handbook of Traumatic Stress Syndromes*, *Counter-Transference in the Treatment of Post-Traumatic Stress Disorder* (Guilford Press), *Assessing Psychological Trauma and PTSD*, and *Core Treatments for PTSD* (Guilford Press).

Research and clinical work developed by Dr. Wilson have led to consultations with the U.S. Army and Navy; Department of Veterans Affairs, The White House; U.S. House and Senate Committees on Veterans Affairs; National Institute of Mental Health; National Science Foundation; Commonwealth of Australia; American Psychiatric Association; American Red Cross; United Nations Office of Humanitarian Affairs and The World Health Organization, where he developed mental health programs during the war in Bosnia in 1994 and 1995.

Dr. Wilson has lectured in the U.S. and abroad on the effects of trauma. Included among his numerous awards and honors are a Presidential Commendation from President Jimmy Carter for his work with Vietnam Veterans; the George Washington Honor Medal from the Freedom Foundation at Valley Forge, PA.; the Vega Award from the American Red Cross for distinguished service during the Persian Gulf War and in the treatment for survivors of US Air Flight No. 405 crash in New York, NY.; and distinguished research awards from national organizations in the field of Post-Traumatic Stress.
