

THE METHOD OF DIFFERENTIATING UNDER THE INTEGRAL SIGN

"I could never resist a definite integral" (G. H. Hardy [Co])

"One thing I never did learn was contour integration. I had learned to do integrals by various methods shown in a book that my high-school physics teacher Mr. Bader had given me. ...

The book also showed how to differentiate parameters under the integral sign-It's a certain operation. It turns out that's not taught very much in the universities; they don't emphasize it. But I caught on how to use that method, and I used that one damn tool again and again. So because I was self-taught using that book, I had peculiar methods of doing integrals.

The result was that, when guys at MIT or Princeton had trouble doing a certain integral, it was because they couldn't do it with the standard methods they had learned in school. If it was contour integration, they would have found it; if it was a simple series expansion, they would have found it. Then I come along and try differentiating under the integral sign, and often it worked. So I got a great reputation for doing integrals, only because my box of tools was different from everybody else's, and they had tried all their tools on it before giving the problem to me." (Richard P. Feynman[F])

Introduction

The *method of differentiating under the integral sign* can be described as follows. Given a function $F(x, y)$ of x and y , one is interested in evaluating

$$R(x) := \int_{-\infty}^{\infty} F(x, y) dy . \quad (1)$$

By differentiating $R(x)$ once or more with respect to x , and using integration by parts or change of variable, one gets a differential equation for $R(x)$. Then one evaluates $R(x)$ and its derivatives in an "easy" point, and then solves the differential equation.

Although termed a "method", differentiating under the integral sign could hardly have been considered more than a trick, and the examples given in the few textbooks that treat it ([Ed]) are rather simple. One notable exception is Melzak's[Me] delightful book, that devotes a whole section to this method.

In this paper we are going to present a unified theory of differentiation under the integral sign for the important and wide class of so-called *holonomic functions*. We will recall the "slow" elimination algorithm of [Z1], and present it in a form that will hopefully lead to a fast version using Buchberger's method of Grobner bases adapted to the Weyl algebra. For the subclass of "hyper-exponential" functions we will give a fast algorithm, that given $F(x, y)$, finds a linear differential equation satisfied by $R(x)$. This "fast" algorithm is a continuous analog of Zeilberger's [Z2] [Z3]

(see also [W-Z]) algorithm for hypergeometric summation, that uses Gosper's[Go] algorithm as a subroutine. In Appendix 1 (which is published in [A-Z]) we give a listing of a MAPLE program that implements this algorithm, while Appendix 2 contains sample inputs and outputs.

While the problem of *indefinite integration* in closed form is completely solved and implemented ([Ri], [No], [Tr], [DST]), there is currently no well-developed theory of definite integration (see [No], 3.2). The present paper can be viewed as a first step toward developing a theory of definite integration.

The Theoretical Foundation

In [Z1] Bernstein's class of holonomic functions is considered, and it is shown how the methodology of holonomic functions and systems forms a natural framework for special function identities. Roughly a function $F(x_1, \dots, x_n)$ is holonomic if it "satisfies as many linear differential equations with polynomial coefficients as possible" (see appendix 4, footnote 1 for the precise definition).

The algebra of linear differential operators with polynomial coefficients in (x_1, \dots, x_n) is called the *Weyl algebra*. It is generated by the "indeterminates" $x_1, \dots, x_n, D_1, \dots, D_n$, that obey the commutation relations

$$x_i x_j = x_j x_i, D_i D_j = D_j D_i, x_i D_j = D_j x_i \quad (i \neq j)$$

and the "uncertainty principle"

$$D_i x_i - x_i D_i = 1,$$

where 1 is the identity operator.

Excellent expositions on the Weyl algebra and Bernstein's theory can be found in [Bj] and [Eh]. It was proved in [Z1](section 6.4), using ideas of Bernstein[Be], that if $F(x, y)$ is holonomic and $P(x, y, D_x, D_y)$ and $Q(x, y, D_x, D_y)$ are operators that generate a "holonomic ideal" then one can "eliminate" y . In other words, it is possible to find operators $A(x, y, D_x, D_y)$ and $B(x, y, D_x, D_y)$ such that

$$S(x, D_x, D_y) = A(x, y, D_x, D_y)P(x, y, D_x, D_y) + B(x, y, D_x, D_y)Q(x, y, D_x, D_y)$$

is independent of y . It follows that $F(x, y)$ is also annihilated by S : $S(x, D_x, D_y)F(x, y) \equiv 0$. One can write

$$S(x, D_x, D_y) = \bar{S}(x, D_x) + D_y S'(x, D_x, D_y). \quad (2)$$

It is possible to show that it is always possible to have $\bar{S} \neq 0$. It follows that

$$\bar{S}(x, D_x)F(x, y) = -D_y S'(x, D_x, D_y)F(x, y). \quad (3)$$

In the applications we have in mind, we will have that $\lim_{|y| \rightarrow \infty} x^n y^m D_x^s D_y^t F(x, y) = 0$ for all integers n, m, s and t . Therefore integrating with respect to y from $-\infty$ to ∞ , we get

$$\bar{S}(x, D_x)R(x) = 0 .$$

It was observed in [Z1] that the slow elimination algorithm for the discrete case, that was an adaptation of Sylvester's dialytic elimination method from commutative algebra, goes verbatim to the continuous case. The hope was raised that Buchberger's fruitful concept of Grobner bases could be used to get a fast elimination algorithm. We now reiterate this hope and make one more observation that should make the elimination even faster.

Observation: In order for things to work we don't need that S' in (2) be independent of y ! Our previous insistence probably made \bar{S} of higher order than necessary.

This leads to the following

Research Problem: Develop a fast algorithm, using Grobner bases in the Weyl algebra ([Ga]), that inputs two operators $P(x, y, D_x, D_y)$ and $Q(x, y, D_x, D_y)$ and outputs operators A, B, C, \bar{S} such that

$$\bar{S}(x, D_x) := AP + BQ + D_y C \tag{4}$$

only depends on x and D_x .

Basically we have to find an element $\bar{S}(x, D_x)$ that does not involve y and D_y , that belongs to the "ideal" generated by P, Q and D_y . But note that this ideal is neither "left" nor "right", and therefore not an ideal at all, in the usual sense of the word. It is "left" with respect to P and Q and "right" with respect to D_y , and so one has to develop an ambidextrous Grobner bases algorithm in the Weyl algebra.

A major step towards this goal was recently achieved by Takayama[Ta].

A related notion to holonomicity is that of D-finiteness, which was considered by Lipshitz[Li]. A formal power series $f(x_1, \dots, x_n)$ is *D-finite* if the vector space generated by all its partial derivatives is finite dimensional over the field of rational functions in (x_1, \dots, x_n) . Every holonomic function is *ipso facto* D-finite, but the converse is not known (see [Ta]). For our present purposes, the elegant elementary approach of Lipshitz[Li] suffices and there is no need to invoke the theory of holonomic functions.

A Detailed Example

In order to make the ideas clear, we will use ad hoc elimination to treat the following integral.

$$R(x) := \int_{-\infty}^{\infty} \exp\left(-\frac{x^2}{y^2} - y^2\right) dy .$$

With $F(x, y) = \exp(-x^2/y^2 - y^2)$ we have

$$\begin{cases} D_x F = (-2x/y^2)F \\ D_y F = (2x^2/y^3 - 2y)F \end{cases}$$

or

$$\begin{cases} (y^2 D_x + 2x)F = 0 \\ (y^3 D_y + 2y^4 - 2x^2)F = 0 \end{cases} .$$

We want to apply $\int_{-\infty}^{\infty} dy$ on these equations. Therefore we want to get rid of all terms containing y , except those of the type $D_y G$. This depends on the fact that

$$\int_{-\infty}^{\infty} D_y G dy = [G]_{-\infty}^{\infty} = 0 ,$$

since we assume that everything in sight tends to zero as $y \rightarrow \pm\infty$. This means that after integration we can ignore all terms starting with D_y (i.e. put $D_y = 0$). Now

$$y^3 D_y = D_y y^3 - 3y^2 ,$$

hence the second equation becomes

$$QF = (D_y y^3 - 3y^2 + 2y^4 - 2x^2)F = 0 .$$

Apply D_x on the left and use the first equation

$$y^2 D_x F = -2xF$$

several times. We obtain

$$\begin{aligned} D_x QF &= D_y D_x y^3 F - 3D_x y^2 F + 2y^2 D_x y^2 F - 2D_x x^2 F \\ &= D_y D_x y^3 F - 3(-2x)F + 2y^2(-2x)F + -2D_x x^2 F . \end{aligned}$$

$$\begin{aligned} D_x^2 QF &= D_y D_x^2 y^3 F + 6D_x x F - 4y^2 (D_x x) F - 2D_x^2 x^2 F \\ &= D_y D_x^2 y^3 F + 6D_x x F - 4y^2 (x D_x + 1) F - 2D_x^2 x^2 F \\ &= D_y D_x^2 y^3 F + 6D_x x F + 8x^2 F - 4y^2 F - 2D_x^2 x^2 F . \end{aligned}$$

$$\begin{aligned} D_x^3 QF &= D_y D_x^3 y^3 F + 6D_x^2 x F + 8D_x x^2 F - 4D_x y^2 F - 2D_x^3 x^2 F = \\ &= D_y D_x^3 y^3 F + 6D_x^2 x F + 8D_x x^2 F + 8xF - 2D_x^3 x^2 F . \end{aligned}$$

Differentiating

$$S(x) := \int_{-\infty}^{\infty} F(x, y) dy$$

with respect to x , we obtain

$$D_x^r S(x) = \int_{-\infty}^{\infty} D_x^r F(x, y) dy .$$

Integrating $D_x^3 QF$, the first term vanishes, and we get

$$(6D_x^2 x + 8D_x x^2 + 8x - 2D_x^3 x^2)S(x) \equiv 0 .$$

Using the rules of "multiplication" in the Weyl algebra, this factors to:

$$(xD_x + 3)(D_x - 2)(D_x + 2)S(x) = 0 .$$

This differential equation has the general solution

$$S(x) = C_1 e^{2x} + C_2 e^{-2x} + C_3 y_3 ,$$

where y_3 satisfies

$$y_3'' - 4y_3 = A/x^3 \text{ for } A \neq 0 .$$

One can show that y_3 cannot be bounded at 0. But

$$S(0) = \int_{-\infty}^{\infty} e^{-y^2} dy = \sqrt{\pi} ,$$

hence $C_3 = 0$. Assume that $x > 0$. Then $S(x) \rightarrow 0$ as $x \rightarrow \infty$ implies that also $C_1 = 0$. It follows that

$$S(x) = \sqrt{\pi} e^{-2x} .$$

The above example has only pedagogical value, since it is done much easier by performing the substitution $t = y - x/y$ on the "obvious" integral $\int_{-\infty}^{\infty} \exp(-t^2) = \pi$ (see Appendix 4, footnote 2) or by an argument that combines differentiation under the integral sign and substitution, that is given in p. 220 of Edwards book [Ed] (reproduced in Appendix 4, footnote 3) . The advantage of the present method is that it is purely mechanical and has been programmed. We really hope that the experts on Grobner bases will develop a fast elimination algorithm.

The Class of Hyperexponential Functions

The discrete analog of the exponential function e^{cx} is the geometric sequence $a_n = c^n$, that has the property that $a_{n+1}/a_n = c$ is constant. An important generalization of the class of geometric sequences is the class of *hypergeometric* sequences, that consist of sequences a_n for which a_{n+1}/a_n is a *rational* function of n . Hypergeometric sequences are important because they are the terms of *hypergeometric series*, by which most of the classical special functions can be expressed.

Since the exponential function can be defined as a function $f(x)$ for which $f'(x)/f(x)$ is a constant, it is natural to define, as the continuous analog of hypergeometric sequences, an *hyperexponential* function to be a function $f(x)$ for which the logarithmic derivative $f'(x)/f(x)$ is a rational function of x .

A function of several variables $F(x_1, \dots, x_n)$ is hyperexponential if the logarithmic derivatives $D_{x_i}F/F$, with respect to every variable x_i , are rational functions of (x_1, \dots, x_n) .

Consider equation (3) where $F(x, y)$ is hyperexponential. Since a hyperexponential function is obviously D-finite (see [Li]), it follows from a result of Lipshitz ([Li], Lemma 3) that there exist operators \bar{S} and S' such that (3) holds. Now set

$$G(x, y) := -S'(x, D_x, D_y)F(x, y) . \quad (5)$$

It is easily proved by induction that for hyperexponential F , $D_x^i D_y^j F/F$ is a rational function for every nonnegative i and j . It follows that $G(x, y)$ is a multiple of $F(x, y)$ by a certain rational function, and thus hyperexponential on its own right. Now equation (3) can be rewritten as

$$\bar{S}(x, D_x)F(x, y) = D_y G(x, y) . \quad (6)$$

Thus we can forget about S' and concentrate our attention on finding the winning pair \bar{S} and G , now that we know that they exist. Suppose you already knew, or guessed, \bar{S} . Then (6) asserts that $\bar{S}(x, D_x)F(x, y)$ can be integrated in closed form with respect to y , and Risch's algorithm [Ri], that is implemented on many symbolic packages, can be used to find $G(x, y)$. However, since \bar{S} is not given, but has to be found, we chose to develop our own algorithm for indefinite integration, that is, in some sense, a special case of Risch's algorithm, but that we will be able to extend to find both \bar{S} and G of (6). This algorithm, that is a continuous analog of Gosper's ([Go], see also [La], [GKP]) decision procedure for indefinite hypergeometric summation, will now be presented.

or: Gosper's Algorithm Translated To The Continuous"

This section follows closely Gosper's [Go] classical paper, and the numbering of the equations in this section correspond to that of Gosper's paper. To distinguish them from the other equations in this paper, they are prefixed with a "G".

Input: A hyperexponential function $a(y)$, i.e. a rational function $P(y)/Q(y)$ such that $a'(y)/a(y) = P(y)/Q(y)$. (Throughout this section $a'(y)$ means $D_y a(y) = \frac{d}{dy} a(y)$.)

Output: A hyperexponential function $S(y)$ such that $S'(y) = a(y)$ if such a hyperexponential function $S(y)$ exists, or the statement " $a(y)$ does not have a hyperexponential indefinite integral".

We first find polynomials $p(y), q(y), r(y)$ such that

$$\frac{(a(y)/p(y))'}{(a(y)/p(y))} = \frac{q(y)}{r(y)} , \quad (G5)$$

where $q(y)$ and $r(y)$ satisfy the condition

$$\gcd(r(y), q(y) - jr'(y)) = 1 \text{ for every non - negative integer } j. \quad (G6)$$

It is always possible to do this for if $\gcd(r(y), q(y) - jr'(y)) = g(y)$, then this common factor can be eliminated by

$$p(y) \leftarrow p(y)g(y)^j, r(y) \leftarrow r(y)/g(y), q(y) \leftarrow j(r(y)/g(y))' + (q(y) - jr'(y))/g(y). \quad (G6')$$

The values of j for which such $g(y)$'s exist can be readily detected as the non-negative integer roots of the resultant of $r(y)$ and $q(y) - jr'(y)$ with respect to y .

We now write

$$S(y) = r(y)f(y)a(y)/p(y) , \quad (G7)$$

where $f(y)$ is to be determined. By using $S'(y) = a(y)$,

$$f(y) = (S(y)/S'(y))p(y)/r(y) ,$$

so $f(y)$ is a rational function whenever $S(y)/S'(y)$ is, (i.e. whenever $S(y)$ is hyperexponential.) By substituting Eq. (G7) into $S'(y) = a(y)$, we get

$$a(y) = r(y)f(y)(a(y)/p(y))' + r(y)f'(y)(a(y)/p(y)) + r'(y)f(y)(a(y)/p(y))$$

Multiplying this through by $p(y)/a(y)$, and using Eq. (G5), we have

$$p(y) = (q(y) + r'(y))f(y) + r(y)f'(y) , \quad (G8)$$

the differential equation for $f(y)$.

Theorem: If $S'(y)/S(y)$ is a rational function of y , then $f(y)$ is a polynomial.

Proof: We already know that $f(y)$ is a rational function when $S'(y)/S(y)$ is, so suppose

$$f(y) = \frac{c(y)}{d(y)} , \quad (G9)$$

where $d(y)$ is a polynomial of positive degree, and

$$\gcd(c(y), d(y)) = 1 . \quad (G9a)$$

Substituting (G9) in (G8) we get

$$qcd + r'cd + r(c'd - cd') = d^2p . \quad (G10)$$

It is always possible to write

$$d(y) = A(y)^k \bar{d}(y) , \text{ where } \gcd(A(y), \bar{d}(y)) = 1, \gcd(A(y), A'(y)) = 1 . \quad (G11)$$

Substituting (G11) in (G10) it is readily seen that $A(y)$ divides $r(y)$, i.e.. for some polynomial $\bar{r}(y)$

$$r(y) = A(y)\bar{r}(y) . \quad (G12)$$

Substituting (G12) in (G10) easily yields that $A(y)$ is also a factor of $q(y) - (k-1)r'(y)$, but this contradicts the assumption (G6), and thus $d(y)$ must be constant, QED.

All that remains is to look for a polynomial $f(y)$ satisfying equation (G8), given $p(y)$, $q(y)$, and $r(y)$. To do this, we must find an upper bound k , for the degree of the polynomial $f(y)$.

Case 1:

$$\deg(r(y)) \leq \deg(q(y) + r'(y)) = l .$$

Setting $f(y) = c_k y^k + O(y^{k-1})$, we get $p(y) = Lc_k y^{k+l} + O(y^{k+l-1})$, where L is a nonzero constant. Since the two sides of the equation must be of equal degree,

$$k = \deg(f(y)) = \deg(p(y)) - l .$$

Case 2:

$$\deg(q(y) + r'(y)) < \deg(r(y)) = l .$$

Estimating

$$f(y) = c_k y^k + c_{k-1} y^{k-1} + O(y^{k-2})$$

and

$$f'(y) = kc_k y^{k-1} + (k-1)c_{k-1} y^{k-2} + O(y^{k-3})$$

in Eq. (G8) leads to

$$p(y) = L(k)c_k y^{k+l-1} + O(y^{k+l-2}) ,$$

where $L(k)$ is linear in k and free of c_k . Let k_0 be the root of $L(k)$. Then, the largest k for which c_k can be nonzero is

$$k = \max\{k_0, \deg(p(y)) - l + 1\}, \text{ if } k_0 \text{ is an integer, or}$$

$$k = \deg(p(y)) - l + 1, \text{ if not.}$$

In either case, if $k < 0$, the indefinite integral $S(y)$ is not hyperexponential; otherwise we can substitute a k th degree polynomial, with $k + 1$ undetermined coefficients, for $f(y)$ in Eq. (G8). Equating like powers of y , we get a system of linear equations whose consistency is equivalent to the existence of a hyperexponential $S(y)$ such that $S'(y) = a(y)$ and whose solution provides $f(y)$, whereupon the indefinite integral, $S(y)$, is given by Eq. (G7).

A Fast Algorithm For Definite Hyperexponential Integration

Consider (1) where $F(x, y)$ is hyperexponential. By the theory of holonomic systems, we know *for sure* that there exist $\bar{S}(x, D_x)$ and a hyperexponential $G(x, y)$ such that

$$\bar{S}(x, D_x)F(x, y) = D_y G(x, y) . \tag{6}$$

We now consider x as an auxiliary parameter and set

$$\bar{S}(x, D_x) = \sum_0^m a_i(x) D_x^i$$

where m is the guessed order of \bar{S} . Letting the a_i be unknown, we evaluate the left of (6), *with the undetermined* $a_i(x)$, and apply the algorithm of section 5 to find the $G(x, y)$. In addition to the unknown coefficients of $f(y)$ (that now depend on x) in this algorithm, we also have the unknowns $a_i(x)$. Since they appear linearly, we can modify the above algorithm and require that the resulting system of linear equations be consistent, and when it is, we get as the solution, not only the information about $G(x, y)$, but also the successful $\bar{S}(x, D_x)$. We first try $m = 0$ and increase m until we get a solution. Note that there is no "trial and error" involved here, and we are *guaranteed* to eventually get a successful m . Furthermore, it is not hard to derive an a priori upper bound for m .

When we use the subroutine of section 5, the left side of (6) already has the form of a polynomial times a hyperexponential function, so the starting value of $p(y)$ is not 1, and we already have a head start.

A listing of a MAPLE program that implements both the algorithms of section 6 and 7 is given in appendix 1, and appendix 2 contains examples of input and output.

The method of differencing under the integral sign

The same idea can be used to find a linear recurrence relation satisfied by

$$a_n := \int_{-\infty}^{\infty} F_n(y) dy ,$$

where both $F'_n(y)/F_n(y)$ and $F_{n+1}(y)/F_n(y)$ are rational functions of n and y , that possibly depend on other variables and parameters. We try a generic recurrence operator applied to $F_n(y)$, and enquire, by the above algorithm, when it has a hyperexponential primitive function with respect to y .

Simple example (Courtesy of L. Euler): If $F_n(y) = y^n e^{-y}$, we have

$$(n + 1 - N)F_n(y) = D_y(yF_n(y)) ,$$

where $Na_n := a_{n+1}$. Integrating w.r.t to y from $-\infty$ to ∞ yields $(n + 1 - N)a_n = 0$, i.e. $a_{n+1} = (n + 1)a_n$, and so $a_n = n!$.

Appendix 3 gives a computer-generated proof of the recurrence that leads to the evaluation of Euler's beta integral as well as four other, less trivial, recurrences.

Applications To The Theory Of Special Functions

It is perhaps surprising that while many deep hypergeometric sum identities are known ([Ba]), all of which can be handled by the algorithm of [Z2] and [Z3], relatively few hyperexponential integral identities of the form (1) are known, where both $F(x, y)$ and $R(x)$ are hyperexponential. In fact, the only non-trivial cases known to us are those that are obtained by applying the change of variable

$$t = x - \frac{a}{x}$$

to the integral $\int_{-\infty}^{\infty} \exp(-t^2) dt = \sqrt{\pi}$, and iterating (see appendix 4, footnote 2). Furthermore, the differential equation that the algorithm outputs is never, in our experience, first order, so one has to resort to comparing initial values, that is much harder to do than in the discrete case ([Z3]). In the discrete case the sums are usually terminating, and checking initial conditions is trivial.

Many definite integral formulas that one can find in integral tables can be handled by the holonomic "slow" algorithm, but few fall into the hyperexponential class. On the other hand, the present algorithm is very useful for proving theorems in the theory of special functions. All the classical families of orthogonal polynomials may be defined in terms of a generating function

$$\sum_{n=0}^{\infty} P_n(x) y^n = A(x, y) , \tag{7}$$

where $A(x, y)$ turns out to be hyperexponential (except for the Jacobi polynomials). Then (7) can be rewritten as

$$P_n(x) = \frac{1}{2\pi i} \int_{|y|=\rho} \frac{A(x, y)}{y^{n+1}} dy .$$

Since the integrand is hyperexponential, one can apply our algorithm to find, and prove, the differential equation satisfied by the sequence $P_n(x)$ defined by (7). Similarly, one can use our algorithm for differencing under the integral sign, outlined in the previous section, to find and prove the linear recurrence equation satisfied by the family. Examples are given in appendices 2 and 3.

Another application is to proving Rodrigues-type formulas(e.g. [Ho], p.9). Here we use Cauchy's formula

$$\frac{d^n}{dx^n} f(x) = \frac{n!}{(2\pi i)^n} \int_{|y-x|=\rho} \frac{f(y)}{(y-x)^{n+1}} dy .$$

By using the algorithms of sections 6 and 7 we can get a differential equation and a recurrence equation respectively.

Another application of the algorithm of section 7 is for finding a pure recurrence relation in n for sequences a_n given by

$$a_n = \text{coeff. of } x^b \text{ in } P(x)^n ,$$

where $P(x)$ is a Laurent polynomial. This is useful in one-dimensional random walk problems.

We will describe how to use the program in the UNIX operating system. Readers who use other operating systems will easily make the appropriate modifications.

Place the following input file in a file called INPUT. You should replace WHATYOUWILL by the full path name of the program file.

In order to use the program, you type on your terminal

After the execution is completed you can read the output file by entering "cat OUTPUT".

The program can find both a differential equation and a recurrence equation. The default is the former case, where *disorcon* is not set to anything. Then A(x,y) is the integrand, B(x) is the

conjectured right side (if known), in which case *expli* is set to 1, and the program itself finds "conj", which is the first order differential operator annihilating $B(x)$. If $B(x)$ is not known explicitly, then we don't set anything for B , but set *expli:=0*. If $B(x)$ is conjectured to satisfy a certain differential equation $conj(x, D)B(x) = 0$, then we set $conj := conj(x, D)$. If we don't know what differential equation $B(x)$ satisfies, then we set *conj:=1*. In every case the output is the differential operator $gorem(x, D)$ and the hyperexponential function $G(x, y)$ such that

$$gorem(x, D)conj(x, D)A(x, y) = D_y G(x, y) .$$

In other words $\bar{S}(x, D) = gorem(x, D)conj(x, D)$. ORDER is the guessed order of $gorem(x, D)$. Note that $A(x, y)$ must always be a function of x and y , and it is always assumed that y is the integration variable (so y is a global variable).

If a recurrence equation is desired, then the integrand, $A(n, y)$, must depend on n and y , and the program finds a recurrence operator, expressed in terms of the shift operator N , $Nf(n) := f(n+1)$. The above input file is the same, only now one sets *disorcon:=discrete*. In the discrete case set *expli:=0* always.

Appendix 2: Some Sample Inputs and Outputs For Finding Differential Equations

With the following input, the program proves the Mehler formula for Hermite polynomials (e.g. [Ho], p. 24, ex. 4).

The Mehler formula came to the limelights when Foata[Fo1] gave a beautiful combinatorial proof that inaugurated the currently very active area of combinatorial special function theory. Unlike the computer-generated proof below, that is a *verification*, Foata's proof is a *derivation*, where every part of the generating function arises naturally. Furthermore, Foata's proof lead naturally to a proof of a multi-variate generalization of the Mehler formula that was accomplished by Foata and Garsia[FG](see also [Fo2]). The theory of holonomic systems is incapable, *even in principle*, of proving multi-variate identities with an *arbitrary* number of variables.

Appendix 4: Footnotes

1.The definition of "holonomic function"

The precise definition of holonomicity is as follows([Bj],p. viii). Recall that the principal symbol of a linear partial differential operator

$$P(x, D) = \sum_{|\alpha| \leq m} a_\alpha(x) D^\alpha$$

is the "highest homogeneous part in the D's":

$$\sigma(P)(x, \zeta) = \sum_{|\alpha|=m} a_\alpha(x) \zeta^\alpha$$

A function or distribution F is holonomic if the ideal of linear partial differential operators with polynomial coefficients annihilating it

$$I_F := \{P(x, D); P(x, D)F = 0\}$$

has the property that the "variety of common zeroes of the principal symbols of the elements of I_F "

$$\{(x, \zeta) \in C^{2n}; \sigma(P)(x, \zeta) = 0, P(x, D) \in I_F\}$$

has the minimal dimension it could have, namely n . (That such a variety cannot have dimension less than n follows from the celebrated Bernstein inequality ([Bj]).

As an application we will show that a wide class of hyperexponential functions is holonomic.

Lemma A.4.1: Let $S(x, y)$ be a rational function: $S(x, y) = P(x, y)/Q(x, y)$ (P, Q polynomials) such that the varieties $(x, y) \in C^2; P(x, y) = 0, Q(x, y) = 0$ and $(x, y) \in C^2; Q_y(x, y)/G(x, y) = 0, Q_x(x, y)/G(x, y) = 0$ ($G := \gcd(Q_x, Q_y)$) and $(x, y) \in C^2; G(x, y) = 0, Q(x, y) = 0$ are zero-dimensional (i.e. consists of a finite set of points) then $F(x, y) := \exp(S)$ is holonomic.

Proof: $F(x, y) = \exp(S(x, y))$ is easily seen to satisfy the following differential equations

$$(Q^2 D_x - (P_x Q - P Q_x))F(x, y) \equiv 0 \tag{i}$$

$$(Q^2D_y - (P_yQ - PQ_y))F(x, y) \equiv 0 . \quad (ii)$$

$(P_yQ - PQ_y)(i) - (P_xQ - PQ_x)(ii)$ yields that $F(x, y)$ also satisfies (since $F(x, y)$ is C^∞ we can "divide" by Q):

$$((P_yQ - PQ_y)D_x - (P_xQ - PQ_x)D_y)F(x, y) \equiv 0 . \quad (iii)$$

Thus the variety of common zeroes of the principal symbols of I_F is a subset of the variety

$$\{(x, y, \zeta_1, \zeta_2) \in \mathbf{C}^4 ; Q^2\zeta_1 = 0, Q^2\zeta_2 = 0, ((P_yQ - PQ_y)\zeta_1 - (P_xQ - PQ_x)\zeta_2 = 0\} ,$$

which is easily seen to be two dimensional. It follows that the variety of zeroes has dimension ≤ 2 , and by Bernstein's inequality it is actually 2 and F is holonomic.

The same method of proof yields that under the condition of the lemma $(P(x, y)/Q(x, y))^\alpha$ is always holonomic, and, since holonomicity is closed under multiplication([Z1]) also any product of such functions.

Let us remark that since holonomic functions are **D**-finite ([Z1], 4.1), the existence of (3) could have also been established by Lipshitz's[Li] method.

2. The Secret Behind Many Definite Integrals

The secret behind many definite integrals is a lemma that can be found in [He]. It is probably not the earliest reference. It is likely that the trick was known to Euler or at least to Cauchy (Herr quotes Cauchy, among others , in the preface).

Lemma:

$$\int_{-\infty}^{\infty} f(x)dx = \int_{-\infty}^{\infty} f(x - \frac{a}{x})dx , a > 0$$

Proof: $t = x - \frac{a}{x}$ if and only if

$$x = \begin{cases} t/2 + \sqrt{t^2/4 + a} & \text{if } x > 0 \\ t/2 - \sqrt{t^2/4 + a} & \text{if } x < 0 \end{cases}$$

so,

$$dx = \begin{cases} 1/2 + t/\sqrt{t^2/4 + a} & \text{if } x > 0 \\ 1/2 - t/\sqrt{t^2/4 + a} & \text{if } x < 0 \end{cases}$$

We thus have

$$\int_0^{\infty} f(x - \frac{a}{x})dx = \int_{-\infty}^{\infty} f(t)(1/2 + t/\sqrt{t^2/4 + a})dt ,$$

$$\int_{-\infty}^0 f(x - \frac{a}{x})dx = \int_{-\infty}^{\infty} f(t)(1/2 - t/\sqrt{t})dt .$$

The proof of the lemma is completed by adding the above two equations.

3. How Feynman would have evaluated the integral of section 3

Since the derivation of the integral

$$R(x) := \int_{-\infty}^{\infty} \exp(-\frac{x^2}{y^2} - y^2)dy ,$$

given in ([Ed], p. 220) is "not as well known as it should be", and is "the argument that Feynman would have used directly", one of the referees suggested that we reproduce this derivation. It runs as follows.

$$R(x) = 2 \int_0^{\infty} \exp(-\frac{x^2}{y^2} - y^2)dy ,$$

so

$$\begin{aligned} R'(x) &= -4x \int_0^{\infty} \exp(-\frac{x^2}{y^2} - y^2) \frac{dy}{y^2} , \\ &= -4x \int_{\infty}^0 \exp(-t^2 - \frac{x^2}{t^2}) (\frac{-xdt}{t^2}) \frac{t^2}{x^2} , \\ &= -2R(x) . \end{aligned}$$

This integrates to $R(x) = Ae^{-2x}$ and $x = 0$ gives $R(0) = \sqrt{\pi}$.
